APPLICATION FOR TEMPORARY OPERATION PERMIT

Note To Applicant: Read All Information Carefully To Determine Your Eligibility

Temporary operation permits (TOPs) may be issued to motor vehicle owners desiring to operate a motor vehicle, otherwise subject to registration in Tennessee, over the streets and highways of the state for a temporary period of thirty (30) days, where it appears that the proposed operation is temporary in character.

Tenn. Code Ann. § 55-4-115 authorizes the issuance of a temporary operation permit to the owner of a motor vehicle who has been unable to obtain a new registration or renew a previous registration for their motor vehicle. One additional temporary operation permit for a period of thirty (30) days may be issued to such owner, if the owner was unable to resolve their original registration issue during the previous thirty (30) day period. Applicants must provide proper identification, supporting documentation and payment of the \$10.00 fee to receive the temporary operation permit.

Applications for temporary operation permits **may be refused** if it appears the owner of the motor vehicle is using the permit as a means to avoid registering the vehicle or if it appears the owner is attempting to circumvent any other statutory requirement.
